

ORDINANCE NO. 4955

AN ORDINANCE relating to candidates for election; providing an alternative form for filing disclosure statements; amending Ordinance 287, Section 1 and K.C.C. 1.04.010.

SECTION 1. Ordinance 287, Section 2, and K.C.C. 1.04.010 is hereby amended to read as follows:

STATEMENT OF CONTRIBUTIONS AND EXPENDITURES. Each candidate for nomination or election to an elective office in King County shall, in compliance with the provisions of Article 6, Section 690 of the King County Charter, execute and file a statement of campaign contributions and expenditures on the ((following)) form or forms required by the Public Disclosure Commission pursuant to Chapter 42.17 of the Revised Code of Washington.
