

ORDINANCE NO. 4962

AN ORDINANCE relating to the annexation of an area known as p-281 to Cascade Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as p-281 to Cascade Sewer District was filed with the County Council effective June 16, 1980.

2. Cascade Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1170 concurred with the proposed annexation.

3. Cascade Sewer District filed a Declaration of Nonsignificant Impact dated December 20, 1979, on the proposed annexation.

4. The County Council held a public hearing on the 7th day of July, 19 80, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the area known as p-281 and described in Section 3 herein is approved.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

1           SECTION 3.   The area known as p-281 to be annexed is  
2 described as follows;

3           Beginning at the Northeast corner of the Northwest  
4 quarter of the Northeast quarter of Section 34,  
5 Township 22 North, Range 5 East, W.M. in King County,  
6 Washington said point being on the existing boundary  
7 of Cascade Sewer District;

8           Thence Southerly along the East line of the West half  
9 of said Northeast quarter to the South line of the  
10 North 697 feet of the Southwest quarter of said  
11 Northeast quarter;

12           Thence Westerly along said South line to the North-  
13 South centerline of said Section 34;

14           Thence Southerly along said North-South centerline  
15 to the South line of the Northwest quarter of said  
16 Section 34;

17           Thence Westerly along the South line to the West line  
18 of the Southeast quarter of said Northwest quarter;

19           Thence Northerly along said West line to the North  
20 line of said Southeast quarter of the Northwest  
21 quarter;

22           Thence Easterly along said North line to the North-South  
23 centerline of said Section 34;

24           Thence Northerly along said North-South centerline  
25 to the North line of said Section 34;

26           Thence Easterly along said North line to the Point  
27 of Beginning.
