## ORDINANCE NO.

## 4971

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map, thereof reclassifying certain property thereon at the request of Raymond A. Pemberton, Building and Land Development Division File No. 281-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Raymond D. Pemberton petitioned on June 15, 1979, that the property described in Section 3 below be reclassified from S-R (Potential RD-3600) to RM-2400-P and this application was assigned Building and Land Development Division File No. 281-79-R.

The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on September 20, 1979, and hearing was held by the Examiner on the matter September 27, 1979. The report of the Examiner was filed with the Clerk of the King County Council on October 29, 1979, and the Council approved the reclassification by Motion No. 4587 on November 5, 1979, subject to conditions which will be satisfied per the "P" suffix.

The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM-2400-P and directs that Area Map W 16-21-4 be
