AN ORDINANCE relating to the annexation of an area known as DS-34 to Des Moines Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as DS-34 to Des Moines Sewer District was filed with the County Council July 1, 1980.
- 2. Des Moines Sewer District has found the petition for annexation to be sufficient and has, by Resolution 1980-20 concurred with the proposed annexation.
- 3. Des Moines Sewer District filed a Declaration of Nonsignificant Impact dated June 25, 1980, on the proposed annexation.
- 4. The County Council held a public hearing on the $\frac{4/2}{2}$ day of $\frac{2}{2}$, 19 $\frac{80}{2}$, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Des Moines Sewer District of the area known as DS-34 and described in Section 3 herein is approved.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.
