ORDINANCE NO. 5123

AN ORDINANCE relating to the annexation of an area known as 24th Avenue South to Val Vue Sewer District.

STATEMENT OF FACT:

- 1. A notice of intenton proposing the annexation of an area known as 24th Avenue South to Val Vue Sewer District was filed with the County Council August 20, 1980.
- 2. Val Vue Sewer District has found the petition for annexation to be sufficient and has, by Resolution 887 concurred with the proposed annexation.
- 3. Val Vue Sewer District filed a Declaration of Non-significant Impact dated July 25, 1980, on the proposed annexation.
- day of <u>September</u>, 19 <u>80</u>, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Val Vue Sewer District of the area known as 24th Avenue South and described in Section 3 herein is approved.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

 SECTION 3. The area known as 24th Avenue South to be annexed is described as follows:
