AN ORDINANCE concurring with the recommendation of the Zoning and Subdivision Examiner to approve subject to conditions (modified) the application for Planned Unit Development petitioned by NEWPORT VILLAGE and designated File No. 131-80-P, and modifying Condition No. 14.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

This Ordinance does hereby adopt and incorporate herein the findings and conclusions contained in the report of the Zoning and Subdivision Examiner dated August 15, 1980 which was filed with the Clerk of the Council on September 3, 1980 to approve subject to conditions (modified) the application for Planned Unit Development petitioned by NEWPORT VILLAGE designated by the Building and Land Development Division, Department of Planning and Community Development, File No. 131-80-P, and the Council does hereby adopt as its action the recommendation(s) contained in said report with the following modification to Condition No. 14:

14. A detailed landscaped plan is needed for the entire site showing the height and type of landscaping to be provided together with significant existing vegetation to be retained. Intensive screening shall be provided around the perimeter of the PUD and near the private outdoor areas of each unit. The landscape screening shall not be less than that required by County ordinance between RM and RS zones. The final plan shall incorporate as many existing trees greater than 12" in diameter as possible. A
