5240 ORDINANCE NO.

AN ORDINANCE relating to the annexation of an area known as "Auburn Heights II" to Lakehaven Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as "Auburn Heights II" to Lakehaven Sewer District was filed with the County Council November 17, 1980.
- 2. Lakehaven Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 80-801 concurred with the proposed annexation.
- 3. Lakehaven Sewer District filed a Declaration of Non-significant Impact dated October 13, 1980, on the proposed annexation.
- 4. The County Council held a public hearing on the 840 day of 0 (centre), 19 80, and has considered the criteria set forth in RCW 56.02.060 .

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Lakehaven Sewer District of the area known as "Auburn Heights II" and described in Section 3 herein is approved. King County Council Annexation Report on "Auburn Heights II" is attached and made a part of this ordinance.

Completion of this annexation does not constitute county SECTION 2. approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

The area known as "Auburn Heights II" to be annexed is SECTION 3. described as follows:
