ORDINANCE NO. 5260

AN ORDINANCE relating to the annexation of an area known as #69-25 to Southwest Suburban Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as #69-25 to Southwest Suburban Sewer District was filed with the County Council November 21, 1980.
- 2. Southwest Suburban Sewer District has found the petition for annexation to be sufficient and has, by Resolution 80-39 concurred with the proposed annexation.
- 3. Southwest Suburban Sewer District filed a Declaration of Nonsignificant Impact dated November 3, 1980, on the proposed annexation.
- 4. The County Council held a public hearing on the and day of December, 19<u>80</u>, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

The annexation by Southwest Suburban Sewer District of the area known as #69-25 and described in Section 3 herein is approved. King County Council Annexation Report on #69-25 is attached and made a part of this ordinance.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 3. The area known as #69-25 to be annexed is described as follows:

Beginning at the intersection of 9th Avenue S.W. and S.W. 160th St.; Thence Southerly along the centerline of 9th Avenue S.W. to the centerline of S.W. 162nd St.; 3 Thence Easterly along the centerline of S.W. 162nd St. to its intersection with the Northerly extension of the centerline of Block 16, Gunther's Highland View Tracts, as recorded in Volume 19 of Plats, page 64, Records of King County, Washington; Thence Southerly along the centerline of said Block 16 and the extension of said centerline to the centerline of S.W. 164th S.; Thence Westerly along the centerline of S.W. 164th St. to its intersection with the Southerly extension of the centerline of Block 13, 8 of said Gunther's Highland View Tracts; Thence Northerly along the centerline of Blocks 13 and 4 of said Gunther's Highland View Tracts and the extension of said centerline 10 to the centerline of S.W. 160th St.; 11 Thence Easterly along the centerline of S.W. 160th St. to the Point of Beginning.
