AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map, thereof reclassifying certain property thereon at the request of Jacobson Homes, Inc., Building and Land Development Division File No. 142-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Jacobson Homes, Inc., petitioned on March 2, 1979, that the property described in Section 3 below be reclassified from S-R (Potential RM-900) and RS-7200 to RM-900 and RM-1800, and this application was assigned Building and Land Development Division File No. 142-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on May 10, 1979 and January 31, 1980, and hearing was held by the Examiner on the matter May 17, 1979, and February 14, 1980. The report of the Examiner was filed with the Clerk of the King County Council on June 19, 1980, and the Council approved the reclassification by Motion No. 4959 on July 14, 1980, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying
