8 ORDINANCE NO. 5287

10 AN ORDINANCE amending King County Ordinance
11 No. 3689, as amended, by amending the written
12 descriptions of the boundaries of the various
13 shoreline environments along the shorelines
of the State, by redesignating certain
property thereon at the request of Lionel
St. Clair, Building and Land Development File
No. 014-79-SD.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. Lionel St. Clair petitioned on July 16, 1979,
16 that the property described in Section 3 below be redesignated
17 from Natural to Conservancy and this application was assigned
Building and Land Development Division File No. 014-79-SD.

18 SECTION 2. The report and recommendation of the Building
19 and Land Development Division was transmitted to the Zoning and
20 Subdivision Examiner on September 10, 1979, and hearings were
21 held by the Examiner on the matter September 18, 1979 and
22 October 14, 1980. The report of the Examiner was filed with
23 the Clerk of the King County Council on December 3, 1980, and
24 the Council approved the redesignation by Motion No. 5113 on
25 December 15, 1980, subject to conditions which will be satis-
field per the short plat approval.

26 SECTION 3. The legal description of the property to be
27 redesignated is attached as Appendix A and is hereby made a
28 part of this ordinance. The above described property is shown
29 on the attached map which is designated Appendix B and is
30 hereby made a part of this ordinance.

1 SECTION 4. The King County Council does hereby amend King
2 County Ordinance No. 3689, as amended, by redesignating that
3 property described and shown in Section 3, Appendix A and
4 Appendix B above, to Conservancy and directs that the Shoreline
5 Environment Designation Maps for STR W 17-23-9 be modified to so
6 designate.

7 SECTION 5. This redesignation is granted subject to con-
8 ditions adopted in Motion No. 5113 and said conditions are
9 incorporated herein as though fully set forth herein.
