ORDINANCE NO.

AN ORDINANCE relating to the annexation of an area known as Shimuzu to King County Water District #90.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Shimuzu to King County Water District #90 was filled with the County Council December 15, 1980.
- 2. King County Water District #90 has found the petition for annexation to be sufficient and has, by Resolution No. 356 concurred with the proposed annexation.
- 3. King County Water District #90 filed a Declaration of Non-significant Impact dated July 1, 1980, on the proposed annexation.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District #90 of the area known as Shimuzu and described in Section 3 herein is approved. King County Council Annexation Report on Shimuzu is attached and made a part of this ordinance.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 3. The area known as Shimuzu to be annexed is described as follows:

Beginning at the NE corner of SW 1/4 of the NE 1/4 of Section 23, Township 23N, Range 5E, M.W., King County, Washington; Thence Southerly along the East line of SW 1/4 of the NE 1/4 of said Section 23 to the SE corner which is also the NE corner of Government Lot 4 of said Section 23. 2 Thence continuing Southerly along the East line of Government Lot 4 of Section 23, Township 23N, Range 5E, W.M. to its intersection with the Northerly line of Ordinary High Water of the Cedar River; Thence Westerly along said Northerly line of Ordinary High Water to its intersection with the following described line; Beginning at a point 500 ft.
