

ORDINANCE NO. 5330

AN ORDINANCE relating to the annexation of an area known as "77-3" to King County Water District No. 124.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as "77-3" to King County Water District No. 124 was filed with the County Council January 7, 1981.

2. King County Water District No. 124 has found the petition for annexation to be sufficient and has, by Resolution No. 321 concurred with the proposed annexation.

3. King County Water District No. 124 filed a Declaration of Nonsignificant Impact dated July 15, 1980, on the proposed annexation.

4. The County Council held a public hearing on the 9th day of February, 19 81, and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District of the area known as "77-3" and described in Section 3 herein is approved.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

1 SECTION 3. The area known as "77-3" to be annexed is
2 described as follows:

3 Beginning at the Northwest corner of the Southwest 1/4 of
4 the Southwest 1/4 of Section 33, Township 22 North, Range
4 East, W.M.;

5 Thence Southerly along the West line of the said Southwest
6 1/4 to a point 330 feet North of the South line of said
6 Section 33;

7 Thence Easterly parallel with said South line to the center
8 line of Primary State Highway No. 1;

9 Thence Northerly along said centerline to the North line
9 of the Southwest 1/4 of said Section 33;

10 Thence Westerly along said North line and the North line of
11 the Southeast 1/4 of Section 32, Township 22 North, Range 4
11 East, W.M., to the Northwest corner of the Northeast 1/4
12 of the Northeast 1/4 of the said Southeast 1/4;

13 Thence Southerly along the West line of said Northeast 1/4
14 of the Northeast 1/4 of the Southeast 1/4 and continuing
14 Southerly along the West line of the Southeast 1/4 of the
14 Northeast 1/4 of the said Southeast 1/4 to the Southwest
15 corner thereof;

16 Thence Easterly along the South line of the said Southeast
17 1/4 of the Northeast 1/4 of the Southeast 1/4 to the South-
17 east corner thereof which is also the Northwest corner of
17 the Southwest 1/4 of the Southwest 1/4 of said Section 33,
18 and the Point of Beginning.
