ORDINANCE NO. 5334

1 AN ORDINANCE making an appropriation in the
2 amount of \$251,446 to the County Road Construc-
3 tion Fund for the construction of the Landsburg
4 Bridge; authorizing a change of scope in the
Landsburg Bridge; amending Ordinance No. 5232;
Section 73, Attachment No. 1, as amended.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. There is hereby approved and adopted an appropria-
7 tion in the amount of \$251,446 to the County Road Construction Fund
8 from Federal Aid Secondary funds in the amount of \$208,865 and a
9 transfer from the County Road Fund of \$42,581 to provide for the
10 construction of the Landsburg Bridge, Capital Improvement Project
11 No. 700381.

12 SECTION 2. There is hereby approved a change of scope to the
13 Landsburg Bridge to authorize the construction of a railroad
14 crossing.

15 SECTION 3. There is hereby approved and adopted an appropria-
16 tion of \$42,581 in the County Road Fund to "Transfer to Fund 386",
17 Capital Improvement Project No. 999977, from the unappropriated
18 fund balance to provide the local funds required for the Landsburg
19 Bridge.

20 SECTION 4. Ordinance No. 5232, Section 73, as amended, is
21 hereby amended to read as follows:

22 The Executive Proposed Capital Budget and Program for 1981 -
23 1986 is incorporated herein as Attachment No. 1 to this ordinance
24 with the following specified amendments, provisos, and modifica-
25 tions. From the several Capital Improvement project funds there
26 are hereby appropriated and authorized to be disbursed the follow-
27 ing amounts for the specific projects identified and contained in
28 Attachment No. 1 of this ordinance as amended and modified herein.

31 PROVIDED THAT:

32 All provisos adopted by the Council in Ordinance No. 5232,

SECTION 5. The project information sheets attached hereto are adopted to amend and revise the 1981 Capital Improvement Program and Budget; amending Ordinance No. 5232, Section 73, Attachment No. 1, as amended.
