AN ORDINANCE amending King County Title 21, by amending the Zoning Map, thereof reclassifying certain property thereon, at the request of John R. Calhoun, et ux, Building and Land Development Division File No. 169-77-R.

SECTION 1. John R. Calhoun, et ux petioned on September 12, 1977, that the property described in Section 3 below be reclassified from S-R (Potential RM-900) to RM-900, and this application was assigned Building and Land Development Division File No. 169-77-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on November 1, 1977 and January 9, 1979, and hearing was held by the Examiner on the matter November 8, 1977 and January 16, 1979. The report of the Examiner was filed with the Clerk of the King County Council on February 8, 1979, and the Council approved the reclassification by Motion No. 4134 on April 9, 1979, subject to conditions which will be satisfied per the "P" suffix,

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A, and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B, and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Title 21, by reclassifying that property described and
