 ORDINANCE NO. 5364

AN ORDINANCE amending King County Title 21, by amending the Zoning Map, thereof adopting a Final Planned Unit Development on certain property thereon at the request of ALLAN W. NICHOLSON, Building and Land Development Division File No. 213-78-P.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Allan W. Nicholson petitioned on November 10,1977, that the planned unit development be adopted on property described in Section 3 below, and this application was assigned Building and Land Development Division File No. 213-78-P.


