ORDINANCE NO. 5368

AN ORDINANCE amending King County Title 21, by amending the Zoning Map, thereof adopting a Final Planned Unit Development on certain property thereon, at the request of WEYERHAUSER REAL ESTATE CO., Building and Land Development Division File No. 271-76-P, Div. 4.
