ORDINANCE NO.

AN ORDINANCE amending King County Title 21, by amending the Zoning Map, thereof adopting a Final Planned Unit Development on certain property thereon, at the request of JESSIE C. GODFREY, Building & Land Development Division File No. 268-79-P.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Jessie C. Godfrey petitioned on May 9, 1979, that the planned unit development be adopted on property described in Section 3 below and this application was assigned Building and Land Development Division File No. 268-79-P.
