ORDINANCE NO. 5440

AN ORDINANCE amending Ordinance No. 5234, relating to property reclassification for SEA-TAC BUSINESS PARK, Building and Land Development Division File No. 226-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. SECTION NO. 1, Ordinance No. 5234, is hereby amended as follows:

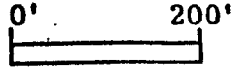
