ORDINANCE NO. 5508

AN ORDINANCE reversing the recommendation of the Zoning and Subdivision Examiner and granting SR-P and RM 1800-P on the application for rezone from SE to SR-P, RM 1800-P, and B-N-P, petitioned by PROVIDENCE POINT and designated File No. 187-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This Ordinance does hereby adopt and incorporate herein the findings and conclusions contained in the report of the Zoning and Subdivision Examiner dated April 8, 1981 which was filed with the Clerk of the Council on May 12, 1981, on the application for reclassification from SE to SR-P, RM 1800-P and B-N-P, petitioned by PROVIDENCE POINT, designated by the Building and Land Development Division, Department of Planning and Community Development, File No. 187-79-R, with the following modifications:

Additional findings:

The change of ownership of the subject property from Sisters of Providence-Pariseau to the Lutheran Bible Institute with the specific intention of providing elderly housing in a complete community devoted to the elderly constitutes a changed circumstance as contemplated by KCC 20.24.162(4).

Additional Conclusion:

Rezoning of the property is permissible under KCC 20.24.162(4).

- SECTION 2. The Council hereby grants SR-P zoning on 173 acres and RM 1800-P on 3 acres as designated in the file on this case, subject to the following conditions:
- 1. Approve RM 1800-P subject to the condition that the only use permitted is a nursing home for elderly or handicapped.
 - 2. Approve SR, subject to the following conditions:
- a) the site shall be subject to PUD approval, at which time the need to provide sprinklers in multistory buildings shall be determined.
- b) Occupancy shall be limited to elderly persons as defined in Ordinance 5280 as now adopted or subsequently amended.
