That KLUMP Precinct shall be created in the following manner and the following described area formerly a part of CHRISTOPHER Precinct, shall hereafter be and constitute a new precinct to be known as KLUMP Precinct:

Area 1: That area lying south of the centerline of South 277th Street; north and west of the south and east boundary of the South 277th Street interchange of State Route 167; west of the centerline of State Route 167; north of the Corporate Limits of Auburn; and east of the centerline of West Valley Highway South.

Area 2: That area lying south of the centerline of South 277th Street; southwest of the centerline of East Valley Highway; west and north of the Corporate City Limits of Auburn; and east of the centerline of 80th Avenue South.

That a New Precinct NATHAN shall be created in the following manner and the following described area, formerly a portion of COVINGTON Precinct, shall constitute the boundaries of NATHAN Precinct:

That area lying south of the centerline of Southeast 288th Street and its extension; east of the west section line of Section 1, Township 21, Range 5; west of the east section line of Section 1, Township 21, Range 5, north of the centerline of Southeast 304th Street.

That a new Precinct PAULA shall be created in the following manner and the following described area, formerly a portion of LOGAN Precinct shall constitute the boundaries of PAULA Precinct:

Beginning at the intersection of the north-south centerline of the east half of Section 16, Township 22, Range 6 and the centerline of Southeast 224th Street; thence east along said Southeast 224th Street centerline to its intersection with the centerline of 132nd Avenue Southeast; thence south along said centerline to its intersection with the centerline of Southeast 234th Street; thence west along said centerline to its intersection with the centerline of 127th Avenue Southeast; thence north along said centerline to its intersection with the centerline of Southeast 233rd Street; thence west along said centerline to its intersection with the north and south centerline of Section 16, Township 22, Range 5; thence north along said centerline to its intersection with the centerline of the north boundary of Meridian Highlands; thence south along said centerline to its intersection with the east-west centerline of the northeast quarter of Section 16, Township 22, Range 5; thence east along said centerline to its intersection with the north-south centerline of the east half of Section 16, Township 22, Range 5; thence north along said centerline to the point of beginning.

That Precinct PHELPS is abolished and the following described area that was formerly a part of PHELPS Precinct shall be combined with and become a part of OXFORD Precinct:

That area lying south of the centerline of Southeast 216th; west of the centerline of 104th Avenue Southeast and its northerly extension; north of the east-west centerline of the northwest quarter of Section 17, Township 22, Range 5 E; and east of the centerline of 100th Avenue Southeast.

That a new Precinct PONY shall be created in the following manner, and the following described area, formerly a portion of NEUWANKUM Precinct shall constitute the boundaries of PONY Precinct:

That area lying south of the centerline of Southeast 400th Street; east of the centerline of 196th Avenue Southeast and its extension thereof; north of the centerline of Southeast 416th Street; west of the centerline of 228th Avenue Southeast and its extension thereof.

That RAMONA Precinct shall be altered in the following manner and the following described area, formerly a part of RAMONA Precinct, be combined with and become a part of SNOPASS Precinct:

That area lying within Section 24, Township 23, Range 8E.

That SANDERS Precinct shall be created in the following manner and the following described area, formerly a part of TIMBERLANE Precinct, shall hereafter be and constitute a new precinct to be known as SANDERS Precinct:

That area lying south of the centerline of Timberlane Way Southeast; west of the centerline of 192nd Avenue Southeast; north of the centerline of Southeast 272nd Street; and east of the north-south centerline of Section 30, Township 22, Range 6E.

That SAND TRAP Precinct shall be created in the following manner and the following described area, formerly a part of Dillon Precinct, shall hereafter be and constitute a new precinct to be known as SAND TRAP Precinct:

That area lying south of the centerline of Southeast 240th Street; west of the centerline of 138th Avenue Southeast; north of the centerline of Southeast 241st Street; west of the centerline of 135th Avenue Southeast; north of the centerline of Southeast 243rd Place; west of the centerline of 133rd Avenue Southeast; west of the centerline of 136th Avenue Southeast; south of the centerline of Southeast 251st Street; west of the west boundary of Meridian Valley Estates; south of the north boundary of Tax Lot 27; west of the east boundary of Tax Lot 27; north of the centerline of Southeast 256th Street; and east of the centerline of 132nd Avenue Southeast.

#### RENTON 53 PRECINCT

That Precinct RENTON 53 will be altered in the following manner and the following described area, formerly part of Renton 27 Precinct, shall be combined with and become part of Renton 53 Precinct:

That area lying south of the centerline of the "Old Renton Corporate Limits" (extension of South Victoria Lane) to its intersection with the centerline of Benson Road South; south along said centerline to its intersection with the centerline of the extension of Southeast 164th Street; west along said centerline to its intersection with the corporate limits of the

City of Renton; south thence west along said limits to its intersection with the centerline of State Route 515; northerly along said centerline to its intersection with the extension of the centerline of South 27th Street; west along said centerline to its intersection with the centerline of Smithers Road South; northerly along said centerline to its intersection with the centerline of South 25th Street; west along said centerline to its intersection with the centerline of Morris Street; south along said centerline to its intersection with the centerline of South 26th Street; westerly along said centerline to its intersection with the centerline of Talbot Road South; northerly along said centerline to its intersection with the centerline of South 23rd Street; westerly along said centerline to the centerline of Shattuck Street South; north along said centerline to its intersection with the centerline of Shattuck Street South; north along said centerline to its intersection with the centerline of the old Renton Corporate Limits, the point of beginning.
