

ORDINANCE NO. 5617

AN ORDINANCE relating to the annexation of an area known as 81-6 to Southwest Suburban Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 81-6 to Southwest Suburban Sewer District was filed with the County Council July 23, 1981.

2. Southwest Suburban Sewer District has found the petition for annexation to be sufficient and has, by Resolution 81-25 concurred with the proposed annexation.

3. Southwest Suburban Sewer District filed a Declaration of Non-significant Impact dated June, 29, 1981, on the proposed annexation.

4. The County Council held a public hearing on the 17th day of August, 19 81, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Southwest Suburban Sewer District of the area known as 81-6 and described in Section 3 herein is approved. King County Council Annexation Report on 81-6 is attached and made a part of this ordinance.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 3. The area known as 81-6 to be annexed is described as follows:

(That portion of the SW 1/4 of Section 5 and the NW 1/4 of Section 8, Township 23 North, Range 4 East, W.M., described as follows:)

Beginning at the Southwest corner of said Section 5;

Thence Northerly along the West line of said Section 5 to its intersection with the Easterly extension of the South line, of Hawima Heights (located on SE 1/4 Section 6, Township 23 North, Range 4 East), according to plat thereof recorded in volume 34 of plats, page 20, records of King

2 Thence Easterly along said Easterly extension to its
3 intersection with a line which is 100 feet Easterly of and
4 parallel with the West line of said Section 5;

5 Thence Northerly along said parallel line to its inter-
6 section with the North line of Lot 16, Block 1 Beverly
7 Park, Div. 1, according to plat thereof recorded in
8 Volume 32 of plats, page 1, records of King County,
9 Washington;

10 Thence Easterly along said North line to its intersection
11 with the North-South centerline of said Block 1;

12 Thence Southerly along said centerline and its Southerly
13 extension to its intersection with the North line of said
14 Section 8;

15 Thence continuing Southerly 2,675 feet more or less to a
16 point on the South line of the said NW 1/4 of Section 8,
17 which is 170.09 feet Easterly of the Southwest corner
18 thereof;


19 Thence Westerly along said line 170.09 feet to its inter-
20 section with the Southwest corner of said Section 8;

21 Thence Northerly along the Westerly line of said Section 8
22 to the Point of Beginning.
