

ORDINANCE NO. 5633

1 AN ORDINANCE making an appropriation in the
 2 amount of \$104,880 to the Arterial Highway
 3 Development Fund for the construction of 15th
 4 Avenue N.E. from unencumbered fund balance of
 5 \$39,593, and from a transfer from the County
 6 Road Fund of \$45,588; cancelling \$19,699 of
 7 existing appropriation for N.E. 132nd Street;
 8 amending Ordinance No. 5232, Sections 73 and
 9 74, Attachment No. 1, as amended.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. There is hereby approved and adopted an appro-
 12 priation of \$109,880 to the Arterial Highway Development Fund for
 13 the construction of 15th Avenue N.E., C.I.P. Project No. 100177
 14 from unencumbered fund balance of \$39,593, from a transfer from
 15 the County Road Fund of \$45,588, and from transferring an appro-
 16 priation of \$19,699 from N.E. 132nd Street.

17 SECTION 2. There is hereby approved and adopted an appro-
 18 priation of \$45,588 from the unencumbered fund balance of the
 19 County Road Fund to "Transfer to Fund 336", C.I.P. Project No.
 20 999878.

21 SECTION 3. \$19,699 in excess funding capacity contained in
 22 N.E. 132nd Street, C.I.P. Project No. 200772 is hereby cancelled.

23 SECTION 4. Ordinance No. 5232, Section 73, as amended, is
 24 hereby amended to read as follows:

25 The Executive Proposed Capital Budget and Program for 1981 -
 26 1986 is incorporated herein as Attachment No. 1 to this ordinance
 27 with the following specified amendments, provisos, and modifica-
 28 tions. From the several Capital Improvement project funds there
 29 are hereby appropriated and authorized to be disbursed the follow-
 30 ing amounts for the specific projects identified and contained in
 31 Attachment No. 1 of this ordinance as amended and modified herein.

County Road (C.I.P. Only)	((\$3,197,572))	<u>\$3,243,160</u>
Arterial Highway Development	((\$1,942,419))	<u>\$2,047,299</u>

32 PROVIDED THAT:

33 All provisos adopted by the Council in Ordinance No. 5232,
 as amended, shall be fulfilled.

1 SECTION 5. Ordinance No. 5232, Section 74, is hereby amended
2 to read as follows:

3 Accumulated unexpended prior years appropriations from several
4 capital improvement project funds for the specific projects identi-
5 fied and contained in Attachment No. 1 to this ordinance are hereby
6 cancelled as follows:

7 County Road Fund -- (C.I.P. Only)	\$171,134
8 County Road Construction	\$218,894
9 Arterial Highway Development ((\$667,960))	<u>\$86,659</u>


10 The County Executive is authorized to adjust the cancelled

16 ment No. 1., as amended.


