The deed was recorded under AF 651209, (Vol. 722 of Deeds, page 224). The subject vacation area as petitioned is estimated to total less than 3,600 quare feet. The vacation area is classified "A Class" in accordance with County Ordinance No. 2759. The County is now in receipt of \$313.00 from the petitioners which has been judged to be just compensation to King County for the vacation area.
