## ordinance No. 5695

AN ORDINANCE making appropriations in the amount of \$2,601,342 to the Grant Fund from State of Washington Referendum 37 grant funds; amending and revising the 1981 Capital Improvement Budget and Program, amending Ordinance No. 5232, Section 73, Attachment No. 1, as amended, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The amount of \$928,759 is hereby appropriated to the Grant Fund from a State of Washington Referendum 37 grant anticipated for construction of a Vocational Educational and Recreation Building, Capital Improvement Project No. R97961, for operation by the Seattle Children's Home.

PROVIDED THAT:

The Seattle Children's Home shall agree to reimburse the County for all costs not reimbursed by the State.

SECTION 2. The amount of \$1,143,087 is hereby appropriated to the Grant Fund from a State of Washington Referendum 37 grant award anticipated for construction of a Center for the Deaf and Hard of Hearing, Capital Improvement Project No. R97962, for operation jointly by the Seattle Hearing and Speech Center with the Community Service Center for the Deaf and Hard of Hearing.

PROVIDED THAT:

The Seattle Hearing and Speech Center and the Community Service Center for the Deaf and Hard of Hearing shall agree to jointly reimburse the county for all costs not reimbursed by the State.

SECTION 3. The amount of \$529,496 is hereby appropriated to the Grant Fund from a State of Washington Referendum 37 grant award anticipated for a Community Home for the Hard to House Mentally Ill, Capital Improvement Project No. R97963, for operation by the Pioneer Cooperative Affiliation.

PROVIDED THAT:

The Pioneer Cooperative Affiliation shall agree to reimburse the County for all costs not reimbursed by the State.
