AN ORDINANCE concurring with the recommendation of the Zoning and Subdivision Examiner to grant preliminary approval of 13 units, subject to conditions, upon the application for a planned unit development petitioned by HUNTINGTON PARK WEST NO. 15, and designated Building and Land Development Division File No. 242-81-P

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This Ordinance does hereby adopt and incorporate herein the findings and conclusions contained in the report of the Zoning and Subdivision Examiner dated September 16, 1981, which was filed with the Clerk of the Council on October 1, 1981, to grant preliminary approval of 13 units, subject to conditions, to the application for a planned unit development petitioned by HUNTINGTON PARK WEST NO. 15, designated by the Building and Land Development Division, Department of Planning and Community Development, File No. 242-31-P and the Council does hereby adopt as its action the recommendation(s) contained in said report.

SECTION 2. Upon the approval of the final planned unit development plan by the Manager of the Building and Land Development Division shall amend the official zoning maps of King County to reflect this action. If a final planned unit development plan which meets all the conditions of this preliminary approval is not submitted to the Manager of the Building and Land Development Division within the time limits (as they may be extended) provided
