I. BUILDING AND LAND DEVELOPMENT DIVISION REPORT:

BALD Recommendation: Approve

The annexation area is included in the projected service area under the Lakehaven Comprehensive Sewer Plan. Size of Parcel: Approximately 10 Acres


