ORDINANCE NO. __5736

AN ORDINANCE amending King County Title 21, as amended, by amending the Zoning Map, thereof reclassifying certain property thereon at the request of SEATTLE REALTY, INC., Building and Land Development Division File No. 137-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. SEATTLE REALTY, INC., petitioned on February 15, 1979, that the property described in Section 3 below be reclassified from G (POTENTIAL S-R) to S-E, and this application was assigned Building and Land Development Division File No. 137-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on April 5, 1979, and hearing was held by the Examiner on April 12, 1979. The report of the Examiner was filed with the Clerk of the King County Council on May 2, 1979, and the Council approved the reclassification by Motion No. 4253 on May 21, 1979, subject to conditions which have now been satisfied.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A, and is hereby made a part of this ordinance. The above described property is shown on the attached map, which is designated Appendix B, and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Title 21, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to S-E,

	and directs that Area map is 34-25-6 be modified to so designate.
