

ORDINANCE NO. 5771

AN ORDINANCE making an appropriation of \$50,450 to the County Road Construction Fund from a contribution from the City of Kirkland in the amount of \$26,150 and from the Lake Washington School District in the amount of \$24,300 for 124th Ave. N.E. @ N.E. 116th Street; transferring \$20,150 from 116th Ave. N.E. @ N.E. 132nd Street and \$19,400 from South 160th Street - Landscaping to 124th Ave. N.E. @ N.E. 116th Street; amending Ordinance No. 5232, Section 73, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$50,450 to the County Road Construction Fund from a contribution from the City of Kirkland in the amount of \$26,150 and from the Lake Washington School District in the amount of \$24,300 to provide for the construction of 124th Avenue N.E. at N.E. 116th Street, Capital Improvement Project No. 200581.

SECTION 2. There is hereby approved and adopted a transfer of \$39,550 to 124th Avenue N.E. @ N.E. 116th Street, Capital Improvement Project No. 200581, from 116th Avenue N.E. at 132nd Street, Capital Improvement Project No. 200381, in the amount of \$20,150 and from South 160th Street - Landscaping, Capital Improvement Project No. 601178, in the amount of \$19,400.

SECTION 3. Ordinance No. 5232, Section 73, as amended, is hereby amended to read as follows:

The Executive Proposed Capital Budget and Program for 1981-1986 is incorporated herein as Attachment No. 1 to this ordinance with the following specified amendments, provisos, and modifications. From the several Capital Improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified and contained in Attachment No. 1 of this ordinance as amended and modified herein.




