ORDINANCE NO. 5935

AN ORDINANCE relating to fees charged for the use of King County Parks and Recreation Facilities, amending Ordinance No. 5783 and K.C.C. 7.08.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 5783 and K.C.C. 7.08.040 are amended to read as follows:

A. FEE STRUCTURED PROGRAM

Class Fees Range \$8.00 per class to \$30.00 per class

Registration Fee \$5.00 per participant per class for all fee structure classes, special events and athletic fee programs and activities requiring pre-registration. \$1.00 per participant for all workshops, special events, seminars meeting one time only (i.e. 1 day)

B. ENTRY AND TOURNAMENT FEES (leagues, tournament and special events fees to include officials, awards, sports equipment, administration fees and association fees)

Women's basketball leagues	\$100-\$500 per team/league
