AN ORDINANCE amending King County Title 21, as amended, by amending the Zoning Map, thereof reclassifying certain property thereon at the request of T. M. DINSMORE, Building & Land Development Division File No. 103-80-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. J. M. DINSMORE petitioned on November 1, 1979, that the property described in Section 3 below be reclassified from G (POTENTIAL M-L) to M-L, and this application was assigned Building and Land Development Division File No. 103-80-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on December 27, 1979, and January 5, 1981, and hearing was held by the Examiner on January 19, 1980, and on January 15, 1981. The report of the Examiner was filed with the Clerk of the King County Council on February 24, 1981, and the Council approved the reclassification by Motion No. 5214 on May 4, 1981, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A, and is hereby made a part of this ordinance. The above described property is shown on the attached map, which is designated Appendix B, and is hereby made a part of this ordinance.
