ORDINANCE NO. 6007

AN ORDINANCE amending King County Title 21, by amending the Zoning Map thereof reclassifying certain property thereon, at the request of ISLAND DISPOSAL, Building and Land Development Division File No. 151-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. ISLAND DISPOSAL petitioned on March 21, 1979, that the property described in Section 3 below be reclassified from G (Potential M-L) to M-L, and this application was assigned Building and Land Development Division File No. 151-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning & Subdivision Examiner on June 8, 1979, and hearing was held by the Examiner on the matter June 14, 1979. The report of the Examiner was filed with the Clerk of the King County Council on August 9, 1979, and the Council approved the reclassification by Motion No. 4566 on October 22, 1979, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A, and is hereby made a part of this ordinance. The above described property is shown on the attached map, which is designated Appendix B, and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Title 21, by reclassifying that property described and shown in Section 3, Appendices A and B above, to M-P-P, and directs that
