9 ORDINANCE NO. 6007

10 AN ORDINANCE amending King County Title 21, by
11 amending the Zoning Map thereof reclassifying
12 certain property thereon, at the request of
ISLAND DISPOSAL, Building and Land Development
Division File No. 151-79-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. ISLAND DISPOSAL petitioned on March 21, 1979, that
15 the property described in Section 3 below be reclassified from G
16 (Potential M-L) to M-L, and this application was assigned Building
17 and Land Development Division File No. 151-79-R.

18 SECTION 2. The report and recommendation of the Building and
19 Land Development Division was transmitted to the Zoning & Subdi-
20 vision Examiner on June 8, 1979, and hearing was held by the
21 Examiner on the matter June 14, 1979. The report of the Examiner
22 was filed with the Clerk of the King County Council on August 9, 1979,
23 and the Council approved the reclassification by Motion No. 4566 on
24 October 22, 1979, subject to conditions which will be satisfied per
25 the "P" suffix.

26 SECTION 3. The legal description of the property to be
27 reclassified is attached as Appendix A, and is hereby made a part
28 of this ordinance. The above described property is shown on the
29 attached map, which is designated Appendix B, and is hereby made a
30 part of this ordinance.

31 SECTION 4. The King County Council does hereby amend King
32 County Title 21, by reclassifying that property described and shown
33 in Section 3, Appendices A and B above, to M-P-P, and directs that

1 Area Map E 6-22-3 be modified to so designate.

2 SECTION 5. This reclassification is granted, subject to
3 conditions adopted in Motion No. 4566, and said conditions are
4 incorporated herein as though fully set forth herein.

5 INTRODUCED AND READ for the first time this 14th
6 day of May, 1979.

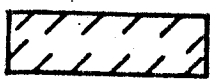

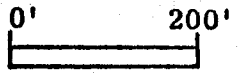
