ORDINANCE NO. 6027

1 AN ORDINANCE relating to fees charged for
2 the use of King County Parks repealing
3 Ordinance No. 5935 and amending Ordinance
4 No. 5783 and K.C.C. 7.08.040.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Ordinance No. 5935 is hereby repealed.

7 SECTION 2. Ordinance No. 5783 and K.C.C. 7.08.040 are
8 amended to read as follows:
