

ORDINANCE NO. 6043

AN ORDINANCE relating to voting precincts in King County amending Ordinance 6039, Attachment B, and declaring an emergency.

PREAMBLE:

The King County Council on June 21, 1982 amended Attachment B. This amendment resulted in two precincts having the same name.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 6039, Attachment B, Page 16 attached hereto and made a part of this ordinance is hereby amended on Line 23 to read as follows:

A portion of Seafair Precinct merges with Skipper Precinct to form New Precinct RKC 46-1107, and called (~~Seafair~~) Skipper.

SECTION 2. The County Council finds as a fact and declares that an emergency exists and that this ordinance is necessary for the immediate preservation of public peace, health or safety or for the support of county government and its existing public institutions.
