ORDINANCE NO. __6048

AN ORDINANCE establishing the date for an election on the question of annexation and assumption of indebtedness to the City of Lake Forest Park of unincorporated territory continguous thereto.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The City of Lake Forest Park, by Resolution 190, has determined that the best interests and general welfare of the City of Lake Forest Park would be served by the annexation of certain unincorporated territory, contiguous thereto and herein described in Section 5.

SECTION 2. Said Resolution does satisfy the provisions of RCW 35A.14.020 requesting the calling of an election to be held among the qualified voters therein upon the question of annexation.

SECTION 3. The King County Boundary Review Board did not receive any request for review and did not choose to invoke jurisdiction, and the sixty day period subsequent to filing having elapsed, said board approved the annexation as of April 20, 1982.

SECTION 4. A special election shall be held on the 14th day of September 1982, or at the next special election date as provided by law, within the territory of the proposed annexation, as hereinafter described, for the purpose of submitting to the qualified electors within the said territory the proposition of annexation and assumption of indebtedness to the City of Lake Forest Park.

<u>SECTION 5</u>. The boundaries of the territory proposed for annexation are hereby described as follows:

All that portion of the South 1/2 of the South 1/2 of the SE 1/4 of Section 4, and the North 1/2 of the NE 1/4 of Section 9, Township 26 North, Range 4 East, W.M., lying Easterly of the following described line:

Beginning at the Northwest corner of Lael Addition as recorded in Volume 52 of Plats, page 100, records of King County, Washington, said point being on the North line of said South 1/2 of the South 1/2 of the SE 1/4 of Section 4; thence south along the West line of said Lael Addition 239.29 feet; thence West 301.42 feet to the East margin of 26th Avenue NE; thence South along the East margin of 26th Avenue NE, 59.1 feet; thence Southeasterly along the East margin of 26th Avenue NE, 165 feet; thence across 26th Avenue NE to a point on the Southwesterly margin of 26th Avenue NE, distant 220 feet Northwesterly from the North margin of NE 185th Street; thence South 32°13'34" West 149.94 feet; thence North 53°15'26" West 75.88 feet; thence North 41°02' West 80 feet; thence South 32°-13'-34" West 150-feet more or less to the Southwesterly margin of Perkins Way, thence Southeasterly along the Southwesterly margin of Perkins Way into Section 9 to its intersection with the South line of the North 1/2 of the NE 1/4 of said Section 9; EXCEPT the portion lying within the existing city limits as established by City Ordinance Nos. 71, 78, 82, 102, 107, 108, 109, 153 and 269. SECTION 6. Notice of election shall be published as required by law. INTRODUCED AND READ for the first time this 14th day of June 1982. PASSED this 12th day of July, 1982.
