13 AN ORDINANCE amending King County Title 21,
14 as amended, by amending the Zoning Map,
15 thereof reclassifying certain property thereon
16 at the request of MARSHALL M. BRENDEN, ET AL,
Building and Land Development Division File
No. 176-78-R.

17 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

18 SECTION 1. Marshall M. Brenden, et al petitioned May 3, 1978,
19 that the property described in Section 3 below be reclassified from
20 S-R (Potential RM-1800) to RM-1800, and this application was
21 assigned Building and Land Development Division File No. 176-78-R.

22 SECTION 2. The report and recommendation of the Building and
23 Land Development Division was transmitted to the Zoning and Subdi-
24 vision Examiner on August 3, 1978, and hearing was held by the
25 Examiner on August 10, 1978. The report of the Examiner was filed
26 with the Clerk of the King County Council on November 13, 1978, and
27 the Council approved the reclassification by Motion No. 3856 on
28 November 20, 1978, subject to conditions which have now been
29 satisfied.

30 SECTION 3. The legal description of the property to be
31 reclassified is attached as Appendix A, and is hereby made a part
32 of this ordinance. The above described property is shown on the
33 attached map, which is designated Appendix B, and is hereby made a

1 part of this ordinance.

2 SECTION 4. The King County Council does hereby amend King
3 County Title 21, as amended, by reclassifying that property
4 described and shown in Section 3, Appendices A and B above, to
5 RM-1800, and directs that Area Map W 16-24-5 be modified to so
6 designate.
