AN ORDINANCE relating to the Vacation of a portion of S. W. 176th Street
Petitioner: Willits A. Smull and Others V-1733

STATEMENT OF FACTS

- A petition has been filed requesting vacation of a portion of
 S.W. 176th Street, hereinafter described.
- 2. The Division of Building and Land Development has studied the proposed road vacation and finds that it would not be in conflict with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed vacation.
- 3. The Department of Public Works has notified the various utilities serving the area and has been advised that easements were obtained by King County Water District No. 75 and Pacific Northwest Bell Telephone Company.
- 4. The vacation area is a portion of right of way in Crescent Beach which was recorded in the Plat records of the County on January 5, 1909. A portion of right of way adjacent to this area was vacated by the County on June 16, 1909. No evidence was found that the vacation area has ever been open as a public road. A search of the records indicates that no public funds have been expended for its acquisition, improvement or maintenance. The road is therefore classified "C" Class in accordance with King County Ordinance No. 2759.
- 5. The Department of Public Works considers the subject vacation area useless as part of the County road system and believes that the public would be benefited by the return of this unused area to the public tax rolls.

Due notice was given in the manner provided by law and a hearing was held by the King County Council on the 23rd day of awyust .

In consideration of the benefits to be derived from the subject vacation, the Council has determined that it is in the best interest of the citizens of King County to grant said petition.
