AN ORDINANCE establishing Solid Waste Operations service fees; repealing Ordinance No. 5231, Section 1; Ordinance No. 5726, Section 1, and K.C.C. 10.12.020.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 5231, Section 1; Ordinance No. 5726 Section 1, and K.C.C. 10.12.020 are each hereby repealed effective January 1, 1983.

NEW SECTION. SECTION 2. All persons using County-operated Solid Waste disposal facilities shall pay the service fees set forth in the following schedule to become effective on January 1, 1983.

A. Service fees for the use of disposal sites with scales shall be:

Year 1983:

Passenger licensed vehicles	\$ 3.50 per entry
Other vehicles	\$26.50 per ton
Minimum charge	\$ 3.50 per vehicle

B. Service fees for the use of disposal sites without scales shall be based upon the cubic yard or fraction thereof as follows:

Year 1983:

Passenger licensed vehicles	\$ 3.50 per entry
Other vehicles	
Compacted Wastes	\$7.90 per cubic yard
Uncompacted Wastes	\$4.40 per cubic yard
Minimum charge	\$3.50 per entry

C. Service fees for Regional Direct landfill users that utilize conventional long-haul transfer vehicles shall be:

Year 1983

Cedar Hills direct	\$11.00 per ton
--------------------	-----------------

1 D. In the absence of exact weights or measurements, the
2 estimate of the superintendent shall be binding upon the user.

3 NEW SECTION. SECTION 3. The Executive is directed to take
4 immediate steps in an effort to negotiate the lease or purchase
5 of the Enumclaw landfill from the City of Enumclaw;

6 NEW SECTION. SECTION 4. Included in the rate structure
7 listed in Section Two of this ordinance is a \$1.50 per ton charge
8 that shall be collected for each ton of solid waste collected in
9 the King County solid waste system which shall be reserved to
10 provide for the replacement and/or reclamation of King County
11 operated landfills.
