### ORDINANCE NO. 6182

AN ORDINANCE relating to the annexation of an area known as Area 5th South and South 146th to King County Water District #20.

#### STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Area 5th South and South 146th to King County Water District #20 was filed with the County Council effective October 5, 1982.
- 2. King County Water District #20 has found the petition for annexation to be sufficient and has, by Resolution No. 490 concurred with the proposed annexation.
- 3. King County Water District #20 filed a Declaration of Non-significant Impact dated March 16, 1982, on the proposed annexation.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District #20 of the area known as Area 5th South and South 146th and described in Section 3 herein is approved. King County Council Annexation Report on Area 5th South and South 146th is attached and made a part of this ordinance.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 3. The area known as Area 5th South and South 146th to be annexed is described as follows:

That portion of the NW 1/4 of the NE 1/4 of the NW 1/4 of Section 20, Tsp. 23N., Rng. 4 E, W.M. in King County, Washington described as follows: All of Lot 4 Cormode's 5 Acre Garden Tracts as recorded in Volume 5 of Plats, page 60, Records of King County, Washington, said Lot 4 includes the replat known as Lambert's Orchard Addition as recorded in Vol. 55 of Plats, page 88, Records of King County, Washington.
