

ORDINANCE NO. 6229

AN ORDINANCE establishing the date of an election on the question of annexation to the City of Normandy Park of an area contiguous to the City, known as the Manhattan area, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The City of Normandy Park, by Resolution No. 418, has determined that the best interests of the City and of adjacent territory would be served by the annexation to the City of an area, known as Manhattan, contiguous to the City on the north, west and south, pursuant to RCW 35.13.015.

SECTION 2. Said resolution does satisfy the provisions of RCW 35.13.015 requesting the calling of an election to be held among the qualified voters therein upon the question of annexation.

SECTION 3. The King County Boundary Review Board, File No. 1114, approved the annexation proposal October 28, 1982.

SECTION 4. A special election shall be held on the 8th day of February, 1983, or at the next special election date as provided by law, within the territory of the proposed annexation, as hereinafter described, for the purpose of submitting to the qualified electors within the said territory the proposition of annexation.

1 SECTION 5. The boundaries of the territory proposed for annexation are
2 hereby described as follows:

3 All of the following described parcels, situated in King County:

- 4 1) All of the NE 1/4 of Section 31, T.23, R. 4, W.M.;
- 5 2) Beginning at the norwest corner of Section 32-23-4, thence southerly along
- 6 the westerly margin of said Section 32 which is the centerline of First
- 7 Avenue South (SR 509) to a point of intersection with the southwest margin
- 8 of the NW-1/4 of said Section 32;

9 Thence easterly 45 feet to the easterly margin of First Avenue South
10 (SR 509);

11 Thence northerly along the easterly margin of First Avenue South (SR 509)
12 to the intersection with the northerly margin of W-1/2 of said Section 32;

13 Thence 45 feet westerly to the point of beginning.

- 14 3) Beginning at the northeast corner of E-1/2 of SE-1/4 of Section 31-23-04;

15 Thence westerly along the northerly margin of the E-1/2 of the SE-1/4
16 of said Section 31 to the west margin of the E-1/2 of said Section 31
17 which is an easterly boundary of the City of Normandy Park, such boundary
18 having been established by King County Resolution 14030 for the Incorpora-
19 tion of the City of Normandy Park on the first day of June, 1953;

20 Thence southerly along said easterly boundary of the City of Normandy Park;

21 Thence easterly and southerly along a northerly and easterly boundary of
22 the City of Normandy Park, as established under City Ordinance No. 89
23 (Colewood Annexation) adopted on the 10th day of April, 1958;

24 Thence continuing southerly along the easterly boundary of the City of
25 Normandy Park, as established under City Ordinance No. 337 (Sorensen
26 Annexation) adopted on the 14th day of December, 1978, and City
27 Ordinance No. 242 (Taylor Annexation) adopted on the 11th day of March,
28 1971;

29 Thence continuing southerly and then easterly along a northerly boundary
30 of the City of Normandy Park, as established under City Ordinance No. 246
31 (Chilton Annexation) adopted on the 9th day of September, 1971;

32 Thence northerly and easterly along a westerly and northerly boundary of
33 the City of Normandy Park, established under King County Resolution No.
14030 for the Incorporation of the City of Normandy Park on the first
day of June, 1953;

Thence continuing easterly along a northerly boundary of the City of
Normandy Park, established under City Ordinance No. 338 (Westchester
Annexation) adopted on the 14th day of December, 1978;

Thence southerly along the westerly margin of First Avenue South which
is also the easterly margin of the Plat of Westchester Addition, accord-
ing to Plat thereof, recorded in Volume 47 of Plats, page 89, Records
of King County, Washington, to a point 19.69 feet south of the NE
corner of Lot 4 of said Plat;

1 Thence easterly 90 feet along the boundary and projection of said
2 boundary of the City of Normandy Park to the easterly margin of
First Avenue South (SR 509);

3 Thence northerly along said easterly margin of First Avenue South
4 (SR 509) to the northerly border of the W-1/2 of SW-1/4 of Section
32-23-04;

5 Thence 45 feet westerly to the point of beginning, situated in
6 King County.

7 SECTION 6. Notice of election shall be published as required by law.

8 SECTION 7. The County Council finds as a fact and declares that an
9 emergency exists and that this ordinance is necessary for the immediate
10 preservation of public peace, health or safety or for the support of county
11 government and its existing public institutions.

13 November, 1982.
