STATEMENT OF FACTS

- 1. A petition has been filed requesting vacation of a portion of Arey Boulevard and Southeast 88th Street.
- 2. The Department of Public Works has notified the various utilities serving the area and has been advised that easements were not required.
- 3. The Division of Building and Land Development has studied the subject proposed road vacation and finds that it would not be in conflict with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed vacation.
- 4. The vacation area is a portion of C.D. Hillman's Lake Washington Garden of Eden Addition to Seattle Division No. 8, which was recorded on January 24, 1908, and a portion of Southeast 88th Street in the Northwest quarter of the Southeast quarter of Section 33, Township 24, Range 5E, W.M. On December 3, 1917, a revised road alignment was established, bypassing the vacation area. The Department of Public Works has found no evidence that the vacation area has ever been open as a public road. A search of the records indicates that no public funds have been expended for its acquisition, improvement, or maintenance. The road is, therefore, classified "C" Class in accordance with King County Ordinance No. 2759.
- 5. The Department of Public Works considers the subject right of way useless as part of the County road system and believes the public would be benefited by the return of this unused area to the public tax rolls.

Due notice was given in the manner provided by law and a

hearing was held by the King County Council on the 22nd day of <u>Sebruary</u>, 1983.

In consideration of the benefits to be derived from the subject vacation, the Council has determined that it is in the best interest of the citizens of King County to grant said petition.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Hillman's Lake Washington Garden of Eden Addition to Seattle Division No. 8 as recorded in Volume 16 of Plats, page 67, records of King County, Washington, lying west of the west line and the southerly extension of the west line of Lot 10, Block 12 and lying east of the east line of Lot 2, Block 11 and lying southerly of the southwesterly right of way margin of S. E. 89th Place known previously as Bartram Station Road when deeded to King County and recorded under AF 1391168 (Volume 1086 of Deeds, page 504).

TOGETHER WITH that portion of Southeast 88th Street, 30 feet in width lying southerly of the south line of said Lot 10, C. D. Hillman's Lake Washington Garden of Eden Addition to Seattle Division No. 8, westerly of the southwesterly margin of Southeast 89th Place and easterly of the southerly extension of the west line of said Lot 10 all located in the northeast quarter of Section 33, Township 24, Range 5E, W.M.
