## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

This Ordinance does hereby adopt and incorporate herein the findings and conclusions contained in the report of the Zoning and Subdivision

Examiner dated April 1, 1983 which was filed with the Clerk of the Council on April 21, 1983, to approve subject to conditions (modified) the Preliminary Plat of MISSION RIDGE ESTATES, designated by the Building and Land Development Division, Department of Planning and Community Development, File No. 677-30, and the Council does hereby adopt as its action the recommendation contained in said report with the following modifications:


## 1) Condition 18 shall read:

The wetland and a 25 foot buffer shall be subject to a native growth protective easement. Covenants on the face of the plat shall prohibit the clearing or removal of trees or vegetation, unless trees or vegetation represent a threat to life or property due to decay or other natural cause. The wetland shall be defined by the 100-year storm elevation established under Condition 17.

## 2) Condition 31 shall read:

The applicant shall drill three auger holes to a depth of 20 feet in the southeast corner of lot 5, the southwest corner of lot 7, and on lot 85, and shall submit the results to the Health Department, and to Surface Water
