

ORDINANCE NO. 6461

AN ORDINANCE relating to solid waste billing procedures for commercial and noncommercial users, amending Section 3, Ordinance 800 as amended and K.C.C. 10.12.030.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Section 3, Ordinance 800 and K.C.C. 10.12.030 is amended to read as follows:

Collection of fees. A. All service fees collected pursuant to this chapter shall be collected in cash by site cashiers at the time of use; provided, that the manager of the King County Solid Waste Division, Department of Public Works (~~and Transportation~~) may authorize a commercial or noncommercial user to be billed monthly for all solid waste delivered to the transfer stations and/or final disposal sites.

B. Authorization of a commercial or noncommercial user's monthly billing shall result from a request in advance for such service by the commercial or noncommercial user. (~~provided, that-are~~)

1. No authorization shall be granted without the posting of an irrevocable payment bond secured by the commercial or noncommercial user in the name of the Solid Waste Division and in an amount which is equal to the actual prior three months of user fee charges.

2. In the absence of prior usage charges, an estimate by the commercial or noncommercial user of three months of usage charges will determine the bond amount.

3. The amount of such bond may be changed by giving of thirty days' notice by the manager to reflect actual usage.

1 4. The manager, shall upon request, relieve a commercial
2 user certified pursuant to Chapter 81.77 RCW of the requirement
3 for an irrevocable payment bond if it has not been delinquent in
4 the preceding 12 months.

5 5. When the monthly bill is delinquent by five days the
6 user shall post within thirty days of the delinquency an
7 irrevocable bond equal to three month's actual charge.

8 6. The manager shall waive the irrevocable payment bond
9 for the following governmental noncommercial users: A municipal
10 corporation, governmental department, agency or commission or
11 political subdivision when he approves its monthly billing
12 request.

13 C. All invoiced fees shall be due and payable to King
14 County, Solid Waste Division, in monthly installments on or
15 before the ~~((last))~~ fifteenth day following the billing date
16 as listed on the invoice or the date of posting, whichever is
17 later. A late payment penalty equal to one and one-half percent
18 (1.5%) of the delinquent unpaid balance, compounded monthly, shall
19 be assessed on the delinquent unpaid balance of those nongovern-
20 mental commercial and noncommercial accounts in arrears. The
21 manager, having given seven days' notice, may suspend use
22 privileges for a commercial or noncommercial user who fails to
23 tender payment ~~((within-two-months-in-arrears:))~~ by the end of the
24 billing month.


25 D. A noncommercial user may be authorized by the manager to
26 be billed monthly for all solid waste delivered to the transfer
27 stations and for final disposal sites; provided, that such non-
28 commercial user is either: 1. A municipal corporation,

1 governmental department, agency or commission, or political
2 subdivision; or 2. a person whose monthly service charges
3 exceed one hundred dollars.
