

ORDINANCE NO. 6490

1 AN ORDINANCE making an appropriation to several
2 agencies for the purpose of paying for goods ordered
3 but not delivered or paid for during the previous
4 fiscal year, amending Ordinance No. 6213, as
5 amended, Sections 4, 5, 16, 18, 20, 24, 28, 29, 31,
6 36, 37, 41, 42, 43, 46, 49, 54, 55, and 56; and
