AN ORDINANCE establishing the date for an election on the question of formation of a park and recreation district encompassing Vashon and Maury Islands, King County, Washington.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to R.C.W. 36.69.020, a petition requesting formation of a park district with boundaries coterminous with Vashon and Maury Islands has been certified by the Records and Elections Division.

SECTION 2. The name of the proposed park and recreation district shall be King County Park and Recreation District No. 2.

SECTION 3. At the general election to be conducted on November 8, 1983, the proposition of formation of a park and recreation district shall be submitted to the qualified electors residing within the proposed district as hereinafter described.

The proposition shall be substantially in the following form:

Shall King County Park and Recreation District No. 2 with boundaries and subdivisions as fully described in King County Ordinance No. 6512 be created?

SECTION 4. The Boundaries of the proposed park and recreation district are described as follows:

All of the islands, known as Vashon and Maury Islands, which lie in Townships 21, 22, and 23 N and Ranges 2 and 3E, W.M., King County, State of Washington.

SECTION 5. The boundaries of the five subdivisions within the park and recreation district are described as follows:

Commissioner District 1: Biloxi, Dolphin, Colvos and Carpenter Precincts.

Commissioner District 2: Dilworth, Baker and Vashon Precincts.

Commissioner District 3: Chatauqua, Lisabeula and Cove Precincts.

Commissioner District 4: Quartermaster, Maury and Dockton Precincts.

Commissioner District 5: Shawnee, Burton and Tahlequah Precincts.


