ORDINANCE NO. 6587

AN ORDINANCE making appropriations to the Grant Fund in the amount of \$211,496, to the Park Acquisition and Development Fund in the amount of \$441,664, and to the County Road Construction Fund in the amount of \$49,187 to implement Community Development Block Grant funded Jobs Bill Projects; amending Ordinance No. 6213, Sections 55, 57, and 76, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$211,496 to the Grant Fund from a transfer from the Community Development Block Grant Fund for Chore Services for Seniors (Work Training) (\$23,000), Summer 1984 Community Service Projects (Work Training) (\$50,000), Senior Center Information and Assistance Program (Human Services) (\$26,867), Business District Project Implementation (Planning) (\$45,379), and King County Parks Comprehensive Plan (\$66,250).

SECTION 2. There is hereby approved and adopted an appropriation of \$441,664 to the Park Acquisition and Development Block Grant Fund for Lakewood Beach Development and Restroom (\$197,023), White Center Rehabilitation and Security (\$72,126), Hamlin Park Paving and Security (\$100,102), and Si View Park Rehabilitation (\$72,413).

SECTION 3. There is hereby approved and adopted an appropriation of \$49,187 to the County Road Construction Fund from a transfer from the Community Development Block Grant Fund for Skyway Park Alley Improvements (\$34,187) and Skyway Intersection Improvements (\$15,000).

SECTION 4. Ordinance No. 6213, Section 76, as amended, is hereby amended to read as follows:
