AN ORDINANCE relating to the vacations of Portions of 30th Avenue South and 32nd Avenue South Petitioner: The Weyerhaeuser Company V-1414, V-1486, V-1529, V-1717, V-1775

STATEMENT OF FACTS

- l. A petition has been filed requesting vacations of portions of 30th Avenue South and 32nd Avenue South, hereinafter described.
- 2. The division of building and land development has studied the proposed road vacations and finds that they would not be in conflict with the principles and purposes of the King county Comprehensive Plan and the specific plans in the vicinity of these proposed vacations.
- 3. The department of public works has notified the various utilities serving the area and was advised that easements have been acquired by Puget Sound Power and Light Company, Washington Natural Gas Company, Pacific Northwest Bell Telephone Company and Water District No. 124.
- 4. King County has acquired deeds for the lands considered necessary as compensation for these road vacations. Both the department of public works and the division of real property agree that the value of the county roads to be vacated has been offset by the value of the lands that the Weyerhaeuser Company has conveyed to King County. Since vacation areas were maintained at county expense for many years, the right of way would therefore be classifed "B" Class in accordance with county ordinance No. 2759.
- 5. The department of public works considers the subject vacation area useless as part of the county road system and believes that the public would be benefited by the return of this unused area to the public tax rolls.
