ORDINANCE NO. 6851

AN ORDINANCE relating to the annexation of an area known as South 158th Street and 42nd Avenue South Annexation to Val Vue Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as South 158th Street and 42nd Avenue South Annexation to Val Vue Sewer District was filed with the county council effective May 21, 1984.
- 2. Val Vue Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1059 concurred with the proposed annexation.
- 3. Val Vue Sewer District filed a Declaration of Non-significant Impact dated May 4, 1984, on the proposed annexation.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Val Vue Sewer District of the area known as South 158th Street and 42nd Avenue South Annexation and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County council annexation report on South 158th Street and 42nd Avenue South Annexation.

SECTION 2. The Val Vue Sewer District is the appropriate entity to serve the area proposed to be annexed.

I. BUILDING AND LAND DEVELOPMENT DIVISION REPORT:
