ORDINANCE NO.

AN ORDINANCE relating to housing and community development; appropriating \$549,000 of federal Rental Rehabilitation Program funds to the Community Development Block Grant Fund, authorizing the King County executive to execute grant agreements for the funds, redistributing Community Development Block Grant funds currently programmed for rental rehabilitation, and amending Ordinance No. 6597, Section 59, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$549,000 to the Community Development Block Grant Fund from an existing 1984 United States Department of Housing and Urban Development, hereinafter referred to as "HUD", grant of \$274,500, and from a pending 1985 HUD grant of \$274,500. Funds are to provide rehabilitation assistance for rental property housing low and moderate income tenants in King County.

SECTION 2. The King County executive is hereby authorized to enter into grant agreements with HUD for the 1984 and 1985 federal Rental Rehabilitation Program funds.

SECTION 3. The existing appropriation for the Low Income Rental Housing Rehabilitation Program shall be redistributed to provide for operation of the federal Rental Rehabilitation Program through December 31, 1985 in an amount not to exceed \$120,000. Any Community Development Block Grant funds remaining after program operation is provided shall be available for reallocation by the county council.

SECTION 4. Ordinance No. 6597, Section 59, as amended, is hereby amended to read as follows:
