ORDINANCE NO. 6929

AN ORDINANCE authorizing the payment of salaries and wages for Seattle-King County Health Department employees covered by the Washington State Nurses Association Collective Bargaining Agreement negotiated and approved by the City of Seattle by Ordinance No. 111783 dated July 9, 1984, for the period September 16, 1983 to August 31, 1984.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Represented employees of the Seattle-King County health department, who are covered by the Washington State Nurses Association Collective Bargaining Agreement negotiated and approved by the City of Seattle by Ordinance No. 111783 shall have their wages and salaries increased in the following manner:

- A. A 1.5% across the board salary increase effective September 16, 1983.
- A shift differential effective June 1, 1984 set at the employees's base hourly rate for nurses working in the jail as follows:

Swing Shift - 2.5% (at top step of Registered Nurse = \$.27/hour).

Night Shift - 3.5% (at top step of Registered Nurse = \$.38/hour)

- C. Nurse Practitioners are to be reimbursed for the application fee for the prescriptive authority license and for the cost of the annual renewal fee.
- D. The rates of pay for the respective classifications effective September 16, 1983 through August 31, 1984:
